

CONSENT AND RELEASE FORM

The posted pool rules at the SugarMill Plantation Pool require anyone entering the facility below the age of 13 to be under the direct supervision of an adult. Adults are defined as SugarMill Residents 18 years or older. Residents 13 to 17 years of age, with the approval of their legal guardian, and upon acceptance of this "Consent and Release" form may utilize the SugarMill Plantation swimming facility.

SugarMill Plantation Owner Association, Inc. (OWNER) does not employ lifeguards at the pool facility.

In consideration of being permitted to use the swimming facility owned by the SugarMill Plantation Owners Association, Inc. for swimming and other permitted uses _____ (GUARDIAN), releaser, on behalf of his/her minor child _____ and personal representatives, heirs and next of kin, hereby covenants not to sue and release, waives and discharges SugarMill Plantation Owners Association, Inc., its officers, members, employees and volunteers, all referred to as "releasees", from all liability to the releaser. Releaser and their personal representatives, assigns, heirs and next of kin further release releasees from all loss or damage, and any claim of damage therefore, on account of injury to the person or property of releaser resulting in the death of releaser, whether caused by negligence of the releasees, or otherwise, while the releaser is swimming at the SugarMill Plantation Pool Facility or using any of the pool facilities.

Releaser agrees to indemnify the releasees and each of them from any loss, liability, damage, or costs releasees may incur due to the presence of releaser in or around the SugarMill Plantation Pool Facility or SugarMill Plantation Owners Association, Inc. property, including its swimming pool and related facilities, whether caused by the negligence of the releasees or otherwise.

Releaser hereby assumes full responsibility for risk of bodily injury, death, or property loss and damage due to the negligence of releasees or otherwise while in or around the SugarMill Plantation Pool Facility, including its swimming pool.

Releaser further releases releasees, public officials and professional personnel and others from any claim whatsoever on account of first aid treatment or services rendered to _____ (CHILD) as a result of use of the SugarMill Plantation Pool Facility or other SugarMill Plantation Owners Association, Inc. property.

Releaser further states that he/she has carefully read the above release and knows the contents of the release and signs this release as his/her own free act. This release contains the entire agreement between parties to this agreement and the terms of this release are contractual and not a mere recital.

This form must have a current picture of the child being authorized under the above agreement attached. Legal guardian completing this form must deliver to the SugarMill Manager, or Pool Attendant on duty, before the child is allowed into the pool area without a parent or guardian.
